A special meeting of the Danube City Council was conducted on October 26, 2016 at 6:00 p.m. with Mayor Gene Alex presiding.

**Purpose of Meeting**

Employee Evaluations and Health Insurance

**Approval of Agenda**

*Councilmember Malvin moved and Councilmember Maurice seconded a motion to approve the Agenda. The motion carried unanimously.*

**Health Insurance**

The Councilmembers reviewed three different health insurance quotes. They discussed the three plans and the difference in coverage along with the cost.

*Councilmember Standfuss moved and Councilmember Krogman seconded a motion to change the current health insurance to the BlueAccess Gold Plan 637. The motion carried unanimously.*

**Evaluations**

The Councilmembers met with each employee present to give them their review results.

*Councilmember Standfuss moved and Councilmember Krogman seconded a motion to award Les Schneider the following raise: \$26.36/per hour increase to \$26.89/per hour. The motion carried with a vote of 4 in favor (Mayor Alex, Councilmember Krogman, Councilmember Malvin and Councilmember Standfuss) to 1 opposed (Councilmember Maurice).*

*Councilmember Maurice moved and Councilmember Standfuss seconded a motion to award Dan Kaufenberg the following raise: \$23.42/per hour increase to \$24.36/per hour. The motion carried unanimously.*

*Councilmember Standfuss moved and Councilmember Krogman seconded a motion to award Dotty Schnobrich the following raise: \$17.50/per hour increase to \$18.38/per hour. The motion carried unanimously.*

*Councilmember Maurice moved and Councilmember Krogman seconded a motion to award Randy Grunke the following raise: \$14.50/per hour increase to \$15.50/per hour. The motion carried with a vote of 4 in favor (Mayor Alex, Councilmember Krogman, Councilmember Maurice and Councilmember Standfuss) and 1 abstained (Councilmember Malvin).*

*Councilmember Standfuss moved and Councilmember Maurice seconded a motion to award Damon Bratsch the following raise: \$16.00/per hour increase to \$18.00/per hour. The motion carried unanimously.*

*Councilmember Krogman moved and Councilmember Maurice seconded a motion to award Les Schneider – maintenance position the following raise: \$15.00/per hour increase to \$18.00/per hour. The motion carried unanimously.*

*Councilmember Maurice moved and Councilmember Standfuss seconded a motion to award Rebecca Pieper the following raise: \$15.00/per hour increase to \$17.00/per hour. The motion carried unanimously.*

*There being no further business before the council, Councilmember Standfuss moved and Councilmember Maurice seconded a motion to adjourn the meeting. With all members voting in favor, the meeting was adjourned at 6:42 p.m.*
